

1 RESOLUTION NO. 22870

2 A RESOLUTION OF THE CITY COUNCIL OF RIVERSIDE, CALIFORNIA,
3 EXTENDING THE TERM OF THE AMERICAN MEDICAL RESPONSE
4 FRANCHISE TO OPERATE AUTHORIZED AMBULANCE VEHICLES TO
5 JUNE 30, 2018.

6 WHEREAS, the City Council by Ordinance No. 6457 granted a franchise to American
7 Medical Response ("AMR"), which ordinance contains in section 2, "TERM" a provision which
8 authorizes the extension of the term of the franchise by resolution within the limits established
9 by the Charter of the City of Riverside; and

10 WHEREAS, the term was originally established for five years with two three year
11 extensions upon mutual concurrence and with further extensions authorized by resolution; and

12 WHEREAS, the term also provided that "the term of this franchise may be further
13 extended by Resolution of the City Council of City"; and

14 WHEREAS, the City Council actions regarding AMR's Franchise are documented in
15 Council approval of Resolutions 20450, 20754, 20829, 21051, 21107, 21370, 22040, 22097 and
16 22411; and

17 WHEREAS, Resolution No. 22411 extended the Franchise to June 30, 2015; and

18 WHEREAS, the City of Riverside and AMR desire to extend the Franchise to June 30,
19 2018; and

20 WHEREAS, the rates set forth in this Resolution are consistent with the rate structure set
21 forth and entered into pursuant to the terms of the Agreement with AMR for ALS First
22 Responder and Ambulance Services dated October 1, 2010.

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside
24 that the term of the Franchise established by Ordinance No. 6457 with AMR for ambulance
25 services in the City of Riverside be extended from July 1, 2015 to June 30, 2018.


26 FURTHERMORE, BE IT RESOLVED by the City Council of the City of Riverside that
