

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE SUBMISSION  
4 OF APPLICATION AND ACCEPTANCE OF GRANT AWARD  
5 FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY  
6 THROUGH THE CALIFORNIA OFFICE OF EMERGENCY  
7 SERVICES FOR THE FISCAL YEAR 2019 STATE HOMELAND  
8 SECURITY PROGRAM GRANT (SHSP), WHICH INCLUDES THE  
9 COUNTYWIDE HAZMAT OPERATION GROUP (CHOG)  
10 PROGRAM, AND AUTHORIZING THE EXECUTION OF ALL  
11 REQUIRED DOCUMENTS BY THE CITY MANAGER OR HIS  
12 DESIGNEE; AND AMENDING THE BUDGET FOR FISCAL  
13 YEAR 2019-2020 ACCORDINGLY.

14 WHEREAS, the U.S. Department of Homeland Security (the “Grantor”) has been delegated  
15 authority to award federal financial assistance for the Fiscal Year 2019 State Homeland Security  
16 Program Grant (SHSP); and

17 WHEREAS, the federal funds have been sub-granted to the California Office of Emergency  
18 Services; and

19 WHEREAS, the County of Riverside is the designated Operational Area to which California  
20 Office of Emergency Services grant funds are awarded and distributed; and

21 WHEREAS, the City desires to apply for and upon grant award, accept the grant award from  
22 the Department of Homeland Security in the amount of \$67,000; and

23 WHEREAS, the City Council desires to amend the annual budget of the City to reflect and  
24 incorporate the Grant so awarded to the City, and to increase the annual appropriations and  
25 expenditures in the appropriate City program to reflect such award.

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
27 California, as follows:

28 Section 1: The City Manager, or his designee, are hereby authorized to submit a grant  
application for and on behalf of the City of Riverside, through the County of Riverside, and are  
hereby authorized to execute all actions necessary for the purpose of obtaining federal financial  
assistance provided by the United States Department of Homeland Security and sub-granted through  
the State of California, including any extensions and amendments thereof.

Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution does, accept the Grant funds in the amount of \$67,000 awarded to the City of Riverside.

Section 3: The City of Riverside hereby agrees to comply with each and all of the terms, conditions, and limitations, imposed by the Grantor upon said Grant, and the City of Riverside City Manager, or his or her designee are hereby authorized and directed to execute the Signature Authority document as well as any agreements, assurance, or other documents as may be necessary in connection with acceptance and implementation of said Grant as may be required by the Grantor.

Section 4: The annual budget of the City of Riverside for fiscal year 2019-2020 is hereby amended by increasing the appropriations and authorized expenditures in such amount as is equal to the amount of Grant funds to be received by the City.
