
Columbia Avenue between East La Cadena Drive and Chicago Avenue

PROPOSAL: Entitlements for commercial development on 1.15-acre vacant site including: (1) General Plan land use designation amendment of project site from MDR - Medium Density Residential to C - Commercial; (2) rezone project site from the R-1-7000 - Single-Family Residential Zone to the CR - Commercial Retail Zone; (3) design review of project plans for construction of four multi-tenant commercial retail and office buildings ranging in size from 3,851 to 5,277 square feet, totaling approximately 18,000 square feet of development; and (4) variance to allow fewer on-site parking spaces than required by Zoning Code.

ENVIRONMENTAL DETERMINATION: The Plannina Commission recommends that the City Council determine that the project will not have a significant effect on the environment based on the findings set forth in the case record and adopt a Mitigated Neaative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP) pursuant to Sections 15074 and 21081.6 of the California Environmental Quality Act (CEQA) Guidelines.
