WHEREAS, on January 16, 2007, the City Council adopted Resolution No. 21322 setting 4 5 forth the Downtown Parking Rate and Hour Schedule for the various Municipal Parking Facilities within the Downtown area; and 6 WHEREAS, Resolution No. 21322 has been amended as follows: 7 8 November 27, 2012, Resolution No. 22478 9 November 19, 2013, Resolution No. 22600 10 December 17, 2013, Resolution No. 22615 January 24, 2017, Resolution No. 23139 11 March 21, 2017, Resolution No. 23160 12 November 13, 2018, Resolution No. 23382; and 13 WHEREAS, above mentioned resolutions establish an annual rental fee for permitted 14 15 parklets; and 16 WHEREAS, the City desires to amend Resolution No. 21322 to temporarily waive the 17 annual rental fees for parklets permitted as part of the Temporary Outdoor Flex Space Permit Program for Restaurants established as part of the COVID-19 economic recovery efforts; and 18 19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 20 California as follows: Section 1: Resolution No. 21322 is hereby amended to waive the parklet annual rental 21 22 fees for parklets temporarily permitted in connection with the COVID-19 economic recovery 23 efforts. Otherwise applicable parking meter fees for parklets temporarily permitted in metered 24 parking spaces in connection with the COVID-19 economic recovery efforts are also waived. 25 Upon such time as a parklet is converted to a permanent permitted parklet, the applicable annual rental fees will become applicable. 26 // 27 28 //
