The City Council approved the required matching funds in the amount of \$37,482.24 for acquisition of a Foam Tender, Bid No. 7733, awarded to Velocity Fire Equipment in the total amount of \$536,482.24 on April 7, 2020, funded through the Riverside Urban Area Security Initiative Grant FY18.

FEDERAL AVIATION ADMINISTRATION GRANT - SUPPLEMENTAL APPROPRIATION - 6951 FLIGHT

AGREEMENT - SPECIAL TRANSPORTATION MINIBUSES
