## ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING THE PROPERTY BOUNDED BY PIERCE STREET ON THE SOUTH, HUGHLEY DRIVE ON THE NORTH, HOLLYHOCK ON THE EAST, AND GOLDEN AVENUE ON THE WEST, FROM THE O – OFFICE ZONE AND R-1-7000 – SINGLE-FAMILY RESIDENTIAL ZONE TO R-3-1500 – MULTIPLE-FAMILY RESIDENTIAL AND O – OFFICE ZONE.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is amended by removing 4.10 acres from the O – Office and R-1-7000 – Single Family Residential Zone to R-3-1500 – Multiple-Family Residential Zone and by removing 0.53 acres from the R-1-7000 Single Family Residential and placing in the O – Office Zone, the property bounded by Pierce Street on the south, Hughley Drive on north, Hollyhock on the east, and Golden Avenue on the West, identified as Assessor's Parcel Nos. 146-141-029, 146-141-065, 146-141-066, 146-141-067, 146-141-071, and 146-141-072, all as described and depicted in Exhibit "A" attached hereto and incorporated herein by reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case Number P19-0554, which conditions, restrictions and covenants are incorporated herein by reference.

Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This Ordinance shall become effective on the 30th day after the date of its adoption.
