

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 19.580.060 AND TABLE 19.580.060 OF THE RIVERSIDE MUNICIPAL CODE.

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 19.580.060 of the Riverside Municipal Code is hereby amended as follows:

**“Section 19.580.060 Parking requirements.**

...

4. When the calculation of the required number of off-street parking spaces results in a fraction of a space, the total number of spaces shall be rounded ~~up~~ to the nearest whole number.

...

E. Cultural Resources Parking Exemption. Any new uses within the confines of an existing structure in a non-residential zone, designated as a historic resource or a contributor to an historic district, as defined in Title 20 on the Riverside Municipal Code, are exempt from providing any additional parking. If an existing structure is expanded, additional parking will be required to accommodate the expansion, as set forth in Table 19.580.060.”

Section 2: Table 19.580.060 of Title 19 of the Riverside Municipal Code entitled “Required Spaces” is hereby amended as shown in Exhibit “A,” attached hereto and incorporated herein by reference.

Section 3: The City hereby finds that this ordinance is not subject to review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15060, subdivision (c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15061, subdivision (b)(3) (there is no possibility the activity in question may have a significant effect on the environment).
