SUBJECT: BOARD OF PUBLIC UTILITIES MEETING SCHEDULE

ISSUE:

The issue for Board of Public Utilities consideration is discussion of its regular meeting time and day.

RECOMMENDATION:

That the Board of Public Utilities revise its Standing Rules to modify the day and time of its Regular Meeting to 6:30 pm on the second and fourth Monday of the month, effective March 2016.

BACKGROUND:

At its Regular Meeting on November 20, 2015, the Board of Public Utilities discussed potential modifications of its Standing Rules to shift the Board's meeting time and day to 6:30 pm the first and third Wednesday of the month effective in March 2015. Subsequent to the Board's direction, staff learned the Art Pick Council Chambers are not available for the Board to meet. The movement of the majority of City Boards and Commissions to the Council Chambers has placed a high demand on its availability.

Subsequent to the Board's November 20 discussion, staff polled Board members individually for availability and recommends the Board consider shifting its meeting to 6:30 pm the second and fourth Monday of the month, effective March 2016.
