

## **MINUTES**

### **TRANSPORTATION BOARD City of Riverside Wednesday, March 4, 2020 5:30 p.m. Art Pick Council Chamber**

Chair Armas called the meeting to order at 5:30 p.m.

#### **APPROVAL OF MINUTES**

Motion was made by Vice Chair Sheth and seconded by Member Soza approving the December 4, 2019, Transportation Board meeting minutes as presented. Member Martin abstained.

Motion carried unanimously.

#### **ORAL COMMUNICATIONS FROM THE AUDIENCE**

Two members of the audience spoke regarding RTA bus drivers, stops and homeless issues at the bus stops. Although they thought this was a City Council meeting, Vice Chair Sheth informed them they could take these matters before City Council. Traffic Engineer, Nathan Mustafa agreed to forward these concerns to RTA.

#### **INFORMATION**

##### **SR-91 / ADAMS STREET – INTERCHANGE RECONFIGURATION – ORAL REPORT BY THUY NGUYEN**

Following discussion motion was made by Member Moran and seconded by Member Martin that the Transportation:

1. Review, receive, and file this report outlining the preliminary findings of the Value Analysis Study related to a potential future reconfiguration project at the SR-91 / Adams Street interchange; and
2. Recommend that the Transportation Committee and City Council continue supporting the interchange project; and
3. Provide feedback on the Oval Roundabout concept design, Alternative 1.1

Motion carried unanimously.

## **CHAIR AND VICE CHAIR ELECTIONS**

Following a vote by paper ballot, Dilesh Sheth was elected Transportation Board Chair and Brandon Bullock was elected Transportation Board Vice Chair.

## **DISCUSSION CALENDAR**

### **MAGNOLIA AVENUE NORTHERLY FRONTAGE ROAD – REMOVAL OF A SEGMENT OF TIMED 1-HOUR PARKING ZONE**

One E-Comment was submitted and was neutral to this item. Following discussion motion was made by Member Alderette and seconded by Vice Chair Sheth recommending that the Transportation Board recommend that the City Council approve:

1. Removal of a segment of the existing “1-Hour Parking between the hours of 7:00 a.m. to 6:00 p.m. of any day except Saturday, Sunday or holidays” zone on the north side of Magnolia Avenue northerly frontage road west of Washington Street; and
2. Revision of the remaining 1-Hour Parking zone boundaries from “Washington Street to a point 550 feet westerly thereof” to “Washington Street to 460 feet westerly thereof”.

Motion carried unanimously.

### **SPEED LIMIT ZONE ESTABLISHMENTS – ARIZONA AVENUE AND MICHIGAN AVENUE**

Following discussion motion was made by Member Soza and seconded by Member Bullock recommending the Transportation Board recommend that the City Council adopt an ordinance to:

1. Establish a 30 MPH speed limit zone on Arizona Avenue from La Sierra Avenue to the easterly terminus; and
2. Establish a 40 MPH speed limit zone on Michigan Avenue from Columbia Avenue to Palmyrita Avenue.

Motion carried unanimously.
