

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF RIVERSIDE, CALIFORNIA,  
3 SETTING FORTH RATES FOR AUTHORIZED AMBULANCE VEHICLES  
4 OPERATING IN THE CITY OF RIVERSIDE.

5 WHEREAS, Riverside Municipal Code Section 5.66.180(A) states that “No ambulance  
6 service shall charge more for its services than the rates and charges approved by the City. Rates  
7 and charges are initially set by Council resolution”: and

8 WHEREAS, the City Council last took action to set forth ambulance rates in Resolution  
9 22870 on June 23, 2015; and

10 WHEREAS, the City Council desires to set forth the rates herein that better reflects the  
11 maximum fees and charges allowed by the Riverside County Emergency Medical Services  
12 Agency (REMS); and

13 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside  
14 that the maximum rates and charges to be charged for ambulance service in the City of Riverside  
15 shall be as follows:
