NOTICE OF PUBLIC HEARING  
PERMANENT LOCAL  
HOUSING ALLOCATION  
5-YEAR ALLOCATION PLAN**

NOTICE IS HEREBY GIVEN that a virtual and/or in-person public hearing will be held in the Art Pick Council Chamber, City Hall, 3900 Main Street, Riverside, California, on Tuesday, July 7, 2020, at 1 p.m., or thereafter, to receive and consider public input on needs and resources relative to a 5-Year Allocation Plan for use of State of California Permanent Local Housing Allocation Funds.

**BACKGROUND:** The State of California established the Permanent Local Housing Allocation (PLHA) Program funded pursuant to Senate Bill (SB) 2 (Chapter 364, Statutes of 2017). The intent of the bill is to provide a permanent, on-going source of funding to local governments for housing-related projects and programs that assist in addressing the unmet housing needs of their local communities. The City's application for PLHA funds requires submission of a 5-Year Allocation Plan. In year one of the Plan, the City proposes to use PLHA funds to fund two housing projects. In subsequent years (2-5) funding would be split between housing project development and management of the City's bridge housing project for homeless individuals.

**PUBLIC REVIEW AND COMMENT PERIOD:** All interested persons are invited to participate at the public hearing to comment on the City's Permanent Local Housing Allocation 5-Year Allocation Plan. In addition, written comments may be submitted to the City prior to the public hearing and during the 10-day public comment period. The draft 5-Year Allocation Plan will be available beginning June 26, 2020, for a 10-day review, ending July 6, 2020, at <https://www.riversideca.gov/homelessolutions/housing-authority/request-proposals> and copies will be mailed upon request.
