SENATE BILL 2

Senate Bill (SB) 2 (Chapter 364, Statutes of 2017) allocates a portion of land transfer taxes to Local governments for eligible housing and homelessness activities. The intent of the bill is to provide a permanent, on-going source of funding to Local governments for housing-related projects and programs that assist in addressing the unmet housing needs of their local communities.



City previously received SB2 for housing planning activities.

ELIGIBLE USES

- 1. Housing Development Activities:
 - a) Predevelopment, development, acquisition, rehabilitation, preservation of multifamily, residential live-work, and rental housing.
- 2. Assisting persons who are experiencing or at risk of homelessness:
 - a) Rental assistance/case management services, operating and capital costs for navigation centers and emergency shelters, and new construction, rehabilitation, and preservation of permanent and transitional housing.

STATE SB2 NOTICE OF FUNDING AVAILABILITY

- 1. Approximately \$195 million available
- 2. 50% to State CDBG entitlement communities allocated proportionately to said governments based on most severe housing needs
- 3. Riverside FY 20/21 Allocation: \$1,622,125
- 4. Five-Year Estimate: \$9,732,750

- 2. Median income of proposed clients
- 3. 10-Day Notice and Public Hearing



Riverside:

- Year 1: 100% to housing development

- Years 2-5: 50% to bridge housing and 50% to development

RECOMMENDATIONS

That the City Council:

- 1. Adopt a five-year funding strategy for use of SB 2 PLHA Program funds;
- 2. Approve the attached Resolution authorizing the City Manager, or designee, to submit a SB 2 PLHA Program application to the California HCD for an amount not to exceed \$1,622,125, and authorizing the City Manager, or designee, to accept and receive such funds and execute any documents necessary to secure such award and administer the grant; and
- 3. Upon award of the grant funds, authorize an increase in revenue in the amount of \$1,622,125 to Development Grants Fund account and appropriate \$1,000,000 to the Golden and Pierce Project account, \$541,019 to The Aspire project account, and \$81,106 to the Permanent Local Housing Allocation Program Administration account.
