Following further discussion, a substitute motion was made by Councilmember Fierro and seconded by Councilwoman Plascencia to (1) conceptually approve acceptance of the funding; and (2) refer the matter to a special City Council Standing Committee meeting on Monday July 27, 2020, for recommendation to the City Council on August 4, 2020. The motion carried with Councilmembers Edwards, Fierro, and Hemenway, and Councilwoman Plascencia voting aye and Councilmembers Melendrez, Conder, and Perry voting no.

Mayor Bailey vetoed the City Council action on the Coronavirus Aid, Relief, and Economic Security Act funding.

ROAD TO COVID-19 RECOVERY FRAMEWORK UPDATE - STATE AND COUNTY GUIDANCE

Following discussion, it was moved by Councilmember Fierro and seconded by Councilmember Perry to (1) receive and order filed the update on Riverside's Road to Recovery Framework adaption across City departments; (2) receive and order filed the update on adoption of state and county published industry guidance for reopening the economy and City actions to keep the workforce safe while providing public services that ensure public health, safety, and welfare; and (3) direct staff to return regularly with updates to the City Council on specific programs, resources, community engagement activities, and other recovery efforts being implemented under the Road to Recovery Framework. AGREEMENT - SOFTWARE, HARDWARE, AND SERVICES FOR AUTOMATED LICENSE PLATE READER PROGRAM

The City Council (1) approved the Enterprise Service Agreement with Lehr Auto Electric to purchase fixed automated license plate reader software, hardware, and services provided by Vigilant Solutions in the amount of \$67,869.56 for the Automated License Plate Reader Program in accordance with Purchasing Resolution No. 22576, Section 602(n) and 702(q); and (2) authorized the City Manager, or designee, to execute the Enterprise Service Agreement with Vigilant Solutions, LLC, and the ability to make non-substantive changes and execute annual renewals for subsequent years in an amount not-to-exceed \$3,000 over the previous year's total amount due, subject to availability of funds.

SHARING HOUSEHOLDS ASSIST RIVERSIDE'S ENERGY PROGRAM

The City Council approved an increase of the Sharing Households Assist Riverside's Energy Program's Electric Monthly Credit from \$14.50 per month to \$15.00 and Water Monthly Credit from \$2.50 per month to \$2.75 to align with electric and water rate increases for Fiscal Year 2020-21.

BID 7739 - TRAFFIC SAFETY EQUIPMENT

The City Council awarded Bid 7739 for procurement of Rectangular Rapid Flashing Beacon devices and LED Edge Lit Stop Signs for the California Office of Traffic Safety grant equipment upgrades at select school crossings to Myers & Sons Hi-Way Safety, Inc., of Chino, CA, in the amount of \$57,403.26.

SPEED LIMIT ZONE - ARIZONA/MICHIGAN - ORDINANCE ADOPTED

FEDERAL TRANSPORTATION ADMINISTRATION CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT GRANT - SPECIAL TRANSPORTATION DIVISION

Hearing was called to consider (1) Charter Review Committee recommendations to place six measures to amend the City Charter on the November 3, 2020, ballot including granting the Mayor a vote, requiring an election to fill an elected office vacancy with more than one year remaining on term, consolidation of Mayor and City Council election dates with statewide elections, submittal of all proposed Charter amendments to Charter Review Committee, publication of annual report on written complaints or whistle-blower complaints alleging fraud, waste, abuse, or criminal conduct, and other clean-up matters; (2) adoption of the appropriate resolutions calling a special election and placing certain proposed City Charter amendments on the November 3, 2020, ballot; and (3) designation of the Mayor or Members of the City Council to author ballot arguments. Five persons spoke on the matter. The public hearing was officially closed. Following discussion, it was moved by Councilmember Perry and seconded by Councilmember Hemenway to (1) adopt a resolution proposing five measures to amend the City Charter including granting the Mayor a vote, requiring an election to fill an elected office vacancy with more than one year remaining on term, consolidation of Mayor and City Council election dates with statewide elections, submittal of all proposed Charter amendments to Charter Review Committee, and other clean-up matters; (2) adopt a resolution calling a special election and placing certain proposed City Charter amendments on the November 3, 2020, ballot; and (3) schedule City Council consideration of an Ordinance requiring publication of an annual report on written

complaints or whistle-blower complaints alleging fraud, waste, abuse, or criminal conduct as soon as possible.

Following further discussion, a substitute motion was made by Councilmember Melendrez and seconded by Councilmember Edwards to place all six proposed measures on the November 3, 2020, ballot.

Following further discussion, a second substitute motion was by Councilwoman Plascencia and seconded by Councilmember Fierro to (1) place four measures on the November 3, 2020, ballot including requiring an election to fill an elected office vacancy with more than one year remaining on term, consolidation of Mayor and City Council election dates with statewide elections, submittal of all proposed Charter amendments to a Charter Review Committee, and other clean-up matters; and (2) refer granting the Mayor a vote and publication of an annual report on written complaints or whistle-blower complaints alleging fraud, waste, abuse, or criminal conduct to an Ad Hoc Charter Review Committee for consideration for placement on the ballot in 2021. The second substitute carried with Councilmembers Fierro, Conder, and Hemenway, and Councilwoman Plascencia voting aye and Councilmembers Edwards, Melendrez, and Perry voting no.

Following further discussion, motion was by Councilwoman Plascencia and seconded by Councilmember Edwards to authorize Councilmember Fierro to author a ballot argument in favor of requiring an election to fill an elected office vacancy with more than one year remaining on the term. The motion carried unanimously.

Whereupon the titles having been read and further readings waived Resolution No. 23609 of the City Council of the City of Riverside, California, Proposing Amendments to the City Charter; and Resolution No. 23610 of the City Council of the City of Riverside, California, Ordering, Calling, Providing for and Giving Notice of a Special Municipal Election to be Held in Said City on the 3rd Day of November 2020, for the Purpose of Submitting to the Qualified Electors of the City of Riverside Certain Amendments to the Charter of the City of Riverside, and Giving Notice and Ordering that Said Special Municipal Election is Consolidated with the Statewide General Election and all Other Elections Being Held in the Same Territory on the Same Date, were presented and adopted.
