## ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTIONS 4.05.050 AND 4.05.060 OF THE RIVERSIDE MUNICIPAL CODE - PUBLIC MEETINGS AND PUBLIC RECORDS.

The City Council of the City of Riverside does ordain as follows:

<u>Section 1</u>: Section 4.05.050(B)(4) of the Riverside Municipal Code is hereby amended to read as follows:

"(4) To correct errors or omissions, or to change a stated financial amount, or to clarify or conform the agenda title to accurately reflect the nature of the action to be taken on the agenda time;".

Section 2: Section 4.05.050(D)(2) of the Riverside Municipal Code is hereby amended to read as follows

"4.05.050(D) Excuse of Sunshine Notice Requirements.

. . .

- (2) If the Mayor or a Council Member, with the concurrence of two other Council Members, believes an item is urgent, which urgency is detailed, in writing, in the Council Report, and affirmed prior to its consideration by five affirmative votes of the City Council with a full quorum present and four affirmative votes if less than a full quorum, and the failure to meet any additional notice requirements was due to:
- (a) The need to take immediate action, which came to the attention of the local body after the agenda was posted, or;
- (b) A software or hardware impairment as defined by Section 4.05.010.H and such additional notice requirements are satisfied no later than 72 hours before the date of the meeting; or..;"

Section 3: Section 4.05.050(D)(4) of the Riverside Municipal Code is hereby amended to read as follows:

"4.05.050(D) Excuse of Sunshine Notice Requirements.

(4) The item was continued by City Council the local body at a regularly noticed City Council meeting to a subsequent City Council meeting."

Section 4.05.060(F) of the Riverside Municipal Code is hereby amended to read as follows:

"(F) Notwithstanding the provisions of subsection (A) through (C) above, a Special Meeting may occur on less than five days' notice if the Mayor or a <u>majority of the Council Member</u>, with the concurrence of another Council Member, believe an item is urgent and there is a need to take immediate action. Any such Special Meeting must comply with the Special Meeting notice requirements of the Brown Act."

Section 5: Section 4.05.060(G) of the Riverside Municipal Code is hereby added as follows:

"(G) To add additional materials or an item to a special meeting agenda after publication, Subsections (C) and (D), respectively, of 4.05.050 above are to be followed and must comply with the requirements of the Brown Act."

Section 6: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 7: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
