1 “4.05.050(D) Excuse of Sunshine Notice Requirements.

2 (4) The item was continued by ~~City Council~~the local body at a regularly noticed ~~City~~
3 ~~Council~~ meeting to a subsequent ~~City Council~~ meeting.”

4 Section 4: Section 4.05.060(F) of the Riverside Municipal Code is hereby amended
5 to read as follows:

6 “(F) Notwithstanding the provisions of subsection (A) through (C) above, a Special
7 Meeting may occur on less than five days’ notice if the Mayor or a majority of the Council
8 ~~Member, with the concurrence of another Council Member~~, believe an item is urgent and there is
9 a need to take immediate action. Any such Special Meeting must comply with the Special
10 Meeting notice requirements of the Brown Act.”

11 Section 5: Section 4.05.060(G) of the Riverside Municipal Code is hereby added as
12 follows:

13 “(G) To add additional materials or an item to a special meeting agenda after
14 publication, Subsections (C) and (D), respectively, of 4.05.050 above are to be followed and
15 must comply with the requirements of the Brown Act.”

16 Section 6: The City Council has reviewed the matter and, based upon the facts and
17 information contained in the staff reports, administrative record, and written and oral testimony,
18 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2),
19 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations,
20 Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical
21 change in the environment nor have a significant impact on the environment.

22 Section 7: The City Clerk shall certify to the adoption of this ordinance and cause
23 publication once in a newspaper of general circulation in accordance with Section 414 of the
24 Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the
25 date of its adoption.
