RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, URGING HCA HEALTHCARE, AREA HOSPITALS AND OTHER HEALTHCARE FACILITIES TO IMPLEMENT HEIGHTENED PROTECTIVE MEASURES FOR FRONTLINE HEALTHCARE WORKERS DUE TO COVID-19.

WHEREAS, the California Emergency Services Act (Government Code § 8550, *et seq.*) empowers the City Council of the City of Riverside to declare a Local Emergency when there exist conditions of disaster or of extreme peril to the safety of persons and property within the territorial limits of the City of Riverside ("City") which are or are likely to be beyond the control of the services, personnel, equipment, and facilities of the City; and

WHEREAS, the City, pursuant to the police powers delegated to it by the Constitution of the State of California, has the authority to enact laws which promote the public health, safety and general welfare of its residents; and

WHEREAS, in accordance with Municipal Code Chapter 9.20.260, The City Council is empowered to enact ordinances, resolutions or rules to prevent against, mitigate, and prepare for aid in the response or recovery to all such foreseeable or unforeseeable emergencies and disasters; and

WHEREAS, during a local emergency the City Council may promulgate orders and regulations necessary to provide for the protection of life and property, such orders and regulations and amendments and rescissions thereof shall be in writing and shall be given widespread publicity and notice.

WHEREAS, as of the writing of this resolution, the Novel Coronavirus (COVID-19) Pandemic has ravaged the Country, State, Region and City of Riverside, with ICU beds at 110% capacity, positivity rate of those tested at 20% Countywide and most critically claiming the lives of 156 Riverside residents and counting; and

WHEREAS, drastic and immediate actions must be taken by the community of Riverside as a whole to contain the spread of COVID-19, protect our public health system and preserve the public health and safety of all residents; and

WHEREAS, Frontline healthcare workers such as doctors, nurses, paramedics, laboratory workers, environmental service workers, and other healthcare staff have been the first line of defense

in the fight against the spread of COVID-19, often putting themselves in great risk of contracting the virus every single day from the patients they serve while doing so; and

WHEREAS, as a result, these healthcare professionals have the potential to put patients, themselves and their families at risk of transmission of COVID-19 due to their prolonged exposures to patients without adequate Personal Protective Equipment such as N95 masks, gloves, booties, hair coverings, face shields, and protective coveralls; and

WHEREAS, due to allegations of understaffing and inadequate PPE, Registered Nurses at Riverside Community Hospital (RCH) issued a strike notice on June 15 and implemented a 10-day strike; and

WHEREAS, Nurses allege that in the COVID-19 and ICU units they care for more patients than they can safely handle, creating an increased risk of negative patient outcomes and preventing nurses from giving their patients the time and attention they need; and

WHEREAS, Riverside Community Hospital is a part of HCA Healthcare, one of the largest and most wealthy hospital corporations in the world; and

WHEREAS, two healthcare workers at Riverside Community Hospital, Environmental Services Worker Rosa Luna and Lab Assistant Sally Lara, have perished from COVID-19 while multiple others have been infected; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1:

a. That the Riverside City Council reaffirms its commitment to frontline healthcare workers in the fight against the spread of COVID-19 and in maintaining the health and safety of healthcare professionals who risk their lives for the well-being of others; and

b. That the Riverside City Council believes that it is absolutely necessary to ensure that healthcare professionals in both the hospital and in-home support service settings should be provided with sufficient Personal Protective Equipment; and

c. That the Riverside City Council understands there is a nationwide shortage of Personal Protective Equipment, including N95 masks, and further commits to assisting healthcare facilities procure PPE; and

d. That the Riverside City Council supports a comprehensive set of guidelines, directives and enforcement be implemented statewide in response to the COVID-19 pandemic that includes both avoiding transmission and caring for patients; and

e. That the Riverside City Council reaffirms its commitment and responsibility to protect and preserve the lives and health of all Riversiders during a time of an unprecedented emergency.

Section 2: In the interest of preserving the safety and health of frontline healthcare workers, patients and the general public, the Riverside City Council imposes the following guidelines for healthcare facilities such as but not limited to hospitals, assisted living facilities and clinics to abide by for the duration of the local emergency:

a. Provide employees with proper and adequate Personal Protective Equipment (PPE), which means including N95 masks, face shields, gloves, gowns, booties, hair coverings, if requested, and always for any employee coming in contact with a probable or confirmed COVID patient, or a hospital worker who has interacted with a hospital worker who has interacted with a COVID patient; and

b. Test patients in advance of scheduled procedures when applicable and before anyone even enters the hospital; and

c. Formulate a strict visitor policy that requires the wearing of face coverings and includes temperature checks and screening for COVID-19 symptoms; and

d. Quarantined healthcare workers must test negative for COVID before they are required by hospital management to come back to work and must be given advance notice before they are required to do so.

e. Ensure sufficient staffing at hospitals so COVID-19 and all patients receive quality care, and, due to furloughs, reduced hours, and staffing cuts, invest in programs so that workers can sign up for additional shifts to keep patients safe,
