Following further discussion, a substitute motion was made by Councilmember Melendrez and seconded by Councilmember Conder to approve the City Council Inclusiveness, Community Engagement, and Governmental Processes Committee recommendation to (1) provide that prior to consideration of matters added to the agenda by three elected officials subsequent to the twelve-day publication, five affirmative votes of the City Council with a full quorum present and four affirmative votes if less than a full quorum are required finding that the documentation provided meets the test of "urgency"; (2) provide that the Mayor or a majority of members of the City Council may call a special meeting with less than five days' notice in conformance with the Brown Act; (3) correct a typographical error by removing the final word "time"; (4) extend the ability to excuse Sunshine Notice requirements to all local bodies for items continued from a prior regularly noticed meeting; and (5) incorporate provisions for adding items and materials to special meeting agendas. The motion failed with Councilmembers Melendrez, Conder, and Perry voting aye and Councilmembers Edwards, Fierro, and Hemenway, and Councilwomen Plascencia voting no.

SIDEWALK VENDORS AND REGULATION OF FOOD FACILITIES - ORDINANCE ADOPTED The City Council adopted an ordinance amending Chapters 5.38 and 6.08 of the Riverside Municipal Code regarding sidewalk vendors and regulation of food facilities to comply with State Law; whereupon, the title having been read and further reading waived, Ordinance No. 7529 of the City of Riverside, California, Amending Sections 5.38.020, 5.38.115, 5.38.130 and 6.08.010 of the Riverside Municipal Code, was presented and adopted.

## BID 7754 - URBAN SEARCH AND RESCUE TRUCK

The City Council (1) awarded Bid 7754 to Fritts Ford, of Riverside, California, for purchase of a Fire/Urban Search and Rescue truck in the amount of \$55,438.23; and (2) authorized the City Manager, or designee, to execute all documents necessary to complete the financing, including making minor and non-substantive changes.

CALIFORNIA CARES HUMANITIES RELIEF PROGRAM - SUPPLEMENTAL APPROPRIATION The City Council (1) approved acceptance of grant funding in the amount of \$15,000 from the California Cares Humanities Relief Program to supplement library adult programming and provide online programs for the community; (2) authorized the City Manager, or designee, to execute grant documents with California Humanities including making minor and non-substantive changes; and (3) authorized an increase in revenue in the amount of \$15,000 and an appropriation in expenditures of the same amount to the Library California Cares Humanities Relief Grant Account.

LIBRARY TRUST AND GIFT FUNDS - LIBRARY MATERIALS, PROGRAMS, AND SERVICES -SUPPLEMENTAL APPROPRIATION

2020 JUSTICE ASSISTANCE GRANT PROGRAM - JOINT APPLICATION - SUPPLEMENTAL **APPROPRIATION** 

The City Council (1) authorized the City of Riverside to submit a joint grant application and to act as fiscal agent for the County of Riverside and all eligible cities within Riverside County for the 2020 Justice Assistance Grant Program with the U.S. Department of Justice, Bureau of Justice Assistance in the amount of \$385,710; (2) approved, upon grant award, acceptance of grant funds in an amount of \$385,710 for the County of Riverside and all eligible cities within Riverside County for the 2020 Justice Assistance Grant Program; (3) authorized the City Manager, or designee, to execute all grant documents, accept all assurances and certifications associated with the grant, and make non-substantive changes; (4) authorized, upon grant award, an increase in the amount of \$385,710 into a trust account and an increase in estimated revenues in the amount of \$385,710 in the grant project revenue account, and appropriate expenditures in the same amount to grant project expenditure account; and (5) transferred and appropriated as spent \$385,710 and any interest earned from the grant trust account.

CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT - SUPPLEMENTAL APPROPRIATION - RESOLUTION

Following discussion, it was moved by Councilmember Fierro and seconded by Councilwoman Plascencia to (1) approve the revised Expenditure Plan for Coronavirus Aid, Relief, and Economic Security (CARES) Act funding as presented with Emergency Operations Center Ops Room furniture for \$100,000 and half of the \$2,262,083 designated for computer replacement removed and reallocated equally to further business and rental assistance; (2) upon receipt of the funds, authorize an increase in revenue and offsetting expenditures in the amount of \$27,991,888 to accounts to be established by the Finance Department; (3) adopt a Resolution waiving the competitive procurement requirements of Purchasing Resolution No. 23256; (4) grant the City Manager, or his designee, the flexibility to reallocate funds from the proposed Expenditure Plan to other similar and eligible uses should feasibility or timeliness concerns arise; (5) authorize the City Manager, or his designee, to negotiate and execute all agreements, contracts and documents related to implementation of the approved Expenditure Plan for CARES Act funding, including making minor non-substantive changes; and (6) direct the City Manager to return to the City Council with expenditure updates at every City Council meeting. The motion carried unanimously.

Whereupon, the title having been read and further reading waived, Resolution No. 23611 of the City Council of Riverside, California, Waiving the Competitive Procurement Requirements of Resolution No. 23256 to Allow for the Purchase of Goods, Products and Services in Connection with the Coronavirus Aid, Relief and Economic Security Funding from the State of California, was presented and adopted.
