**NOTICE IS HEREBY GIVEN** that the City of Riverside has prepared its draft amendment to the HUD Annual Action Plan for program years 2019-2020. The publication of this notice is the beginning of the public review period required under Federal Regulation 21 CFR 91.105 (b)(2). The public review and written comment period begins August 1, 2020, and runs through August 31, 2020.

At this meeting, the City Council will receive public comment on the draft HUD Annual Action Plan 2019-2020 that is to be submitted to the U.S. Department of Housing and Urban Development (HUD).

## BACKGROUND

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside's Five-Year Consolidated Plan (Con Plan) in 2015. The Con Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources [such as Community Development Block Grant funds (CDBG), HOME, Housing Opportunities for People with AIDS (HOPWA), and Emergency Shelter Grants (ESG)] needed to continue implementing existing programs and activities and to formulate programs and activities needed to address the unmet needs. Since the approval of the Con Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2019-2020 implements the strategy and goals identified in the Con Plan.

Federal Regulation 24 CFR 91.105 requires the City to notify and provide its citizens an opportunity to comment and provide input on proposed changes to an approved plan. This notice serves this purpose and allows the City to comply with the law. The proposed Substantial Amendment to the approved Plan affected by this Notice will allow the City to allocate an additional \$116,000 of unprogrammed CDBG funds to the current Bobby Bonds Park Synthetic Turf Replacement Project. This project was originally included in the 2019-2020 Action Plan with an allocation of \$285,345 in CDBG funding. The additional amount will bring the total CDBG funds allocated to this project to \$401,345.
