

On behalf of Western Municipal Water District (Western), we are proud to support the renaming of N. Arroyo Trail after former Director Robert "Bob" Stockton.

As you are all likely aware, Bob was an elected board member to Western and represented Division 1 since 2014. The loss of our former Director on May 13, 2020, has resulted in much heartbreak and change for Western. RE: Bob Stockton Memorial Trail @ Sycamore Canyon

Honorable Commissioners:

Advocate. Mentor. Partner. When I was asked to share just three words to describe Bob Stockton that's how I best described my friend when we celebrated his life back in June.

Advocate:

I knew Bob first as an Advocate; we served together on the YWCA Board of Directors. Bob was committed, diligent, and giving as he pushed forward the mission of YWCA of empowering women and eliminating racism. Sitting across the table from Bob I learned what being an effective board member and compassionate community leader was all about. The more I came to know Bob the more I learned about his advocacy of our community. Bob did it all. He was a principal at his engineering firm, chairman for the chamber, coach for Woodcrest Christian mountain biking team, leader of the Riverside Adventure Group, elected member of Western Municipal Water District, governor appointee for the board for Professional engineers, on the board for Path of Life and other non-profits; I think all at the same time!

Mentor:

You know the scene in Empire Strikes Back where Luke lands on Dagobah and meets Yoda for the first time and he begins his training? I have a picture of Bob and me where I am him on my back during a race and it reminds me of that scene where Yoda is calmly and wisely giving instructions to Luke as he is struggling and sweating through the training. This is the same scene where the master corrects his apprentice and says "Try Not. Do or do not. There is no try." Bob was my mentor. He was my Yoda. He was small in stature, strong, wise, loyal, a trainer, a teacher, a mentor and stubborn. Just like Yoda, you did not want to make him mad or let him down. With Bob you didn't try, you "did". You didn't try to be better, you were better. You didn't try to be a better dad or husband you just did. You didn't try to make your community better, you made your community better. Bob was the master of his family, his friends and his community and we were all his apprentices. I know Bob was a mentor to countless individuals; old and young, male and female, Bob was willing to mentor anyone he came into contact with.

Partner:

Whether it was at a meeting, fundraiser, event or just a morning run Bob would always greet me with a smile and a hug and an energetic "hey partner". He always called me "partner". Bob and I were literally partners in 2014 when we competed in the Endeavor Team Challenge, a 2 day endurance competition we completed together with our friends Nick and Sydnee. But Bob was more than just my training partner or my race partner. Bob was my partner when I campaigned for the RUSD Board of Education. Bob was my partner providing encouragement and wisdom as my business grew. Bob was my partner when I needed his thoughts on family. It was an honor to be Bob's partner; I hope he felt the same way.

I share these personal insights with the honorable commissioners of the Parks and Recreation Commission to show how one man made such a positive impact on my life. Since Bob's passing, I've learned that Bob just didn't have this impact on me and my friends, but countless individuals in our community.

When Bob wasn't advocating for our region, mentoring peers and youth, or guiding his friends and family through different stages in their lives, he was outside; running, swimming, hiking, or biking. His favorite place to "play" was in Sycamore Canyon. Bob has likely covered more mileage in Sycamore Canyon than just about anyone. I can think of no greater way to honor Bob Stockton and to further his legacy than to name the North Arroyo Trail in Sycamore Canyon the Bob Stockton Memorial Trail.

That trail was like Bob's backyard. Naming the trail after Bob will provide a constant reminder of all those that visit Sycamore Canyon of one of Riverside's greatest of all time. It is with great honor, excitement, and energy that request your commission to approve the renaming of the trail in Bob's honor.

With your approval, I greatly look forward to soon joining my friends for an inaugural run on the Bob Stockton Memorial Trail in Sycamore Canyon. Thank you in advance for your consideration.


My name is Damien O'Farrell, and I am a resident of Riverside, Ward 1. I am writing in support of the proposal to rename the N. Arroyo Trail in Sycamore Canyon Wilderness Park in memory of Bob Stockton.

Bob Stockton epitomized community service and leadership and set the example for citizens throughout our City and Region about not only how to engage civically, but also how to live life well and to the fullest. His list of accomplishments and public contributions is extensive including service on the Riverside Planning Commission, the Riverside Board of Public Utilities, the Western Municipal Water District, the Monday Morning Group, the Greater Riverside Chamber of Commerce Board, the YWCA Board of Directors, the Woodcrest Christian Mountain Biking club, and the Board of Path of Life Ministries. It is in this last capacity that I knew Bob most closely, as I served as its CEO until February 2019. It's fair to say that its unlikely that the organization would be in existence today if it were not for Bob's support at critical times.

Just one of the ways that so many strive to be like Bob is in the way that he loved adventure of all kinds and committed himself to caring for creation, being outdoors, and living a fit and healthy life. Bob could run, bike, and climb circles around people a quarter of his age. One of his favorite places to exercise and explore was the N. Arroyo Trail in Sycamore Canyon Wilderness Park; and it's very likely that 100's of community members experienced the trail for the first time either with or because of Bob Stockton. Thank you for considering renaming the N. Arroyo Trail in Sycamore Canyon Wilderness Park in memory of Robert (Bob) Stockton. Bob lived a life of leadership and service commensurate with this naming, and I celebrate our City for considering such a decision.

Bob lived his days in service to others, whether professionally, civically, or as a volunteer. Bob had many professional accomplishments; he was a Partner in his firm, where he worked for 40 years, and sat in statewide leadership positions for the engineering field. As a Civil Engineer, Bob also led many important projects that benefitted the City of Riverside, and most recently the Northside Specific Plan. Bob also worked on numerous efforts to protect our City's infrastructure; over the years, he was appointed and served as Chair of the City's Board of Public Utilities and elected to serve on the Board of Directors for Western Municipal Water District. Bob served our business community in major ways as Chair of the Greater Riverside Chambers of Commerce and also held other various volunteer roles within the Chamber's board and committees, including the task force to recruit CARB to Riverside. He volunteered for charitable organizations, serving local homeless individuals as board chair of Path of Life and providing meals for seniors at the Janet Goeske Center. However, these efforts did not fully define Bob; in fact, if even possible, his legacy lives even more vibrantly in the lives that he personally poured over as a coach and a mentor.

In his life, I believe Bob was proudest of his beloved wife, Kelli, and of their children. Following them, though, Bob deeply adored his athletes. Over the years, he trained and mentored hundreds of athletes, including triathletes, runners, cyclists, and others. He volunteered for more than 10 years as coach to local teens on the Woodcrest Christian School Mountain Bike Team, teaching and mentoring many youth along the way. He used Riverside's roads, trails, and parks in his coaching, and spent countless hours training athletes on the N. Arroyo Trail in Sycamore Canyon. Humbly, I am lucky enough to be one of those athletes, and the word on the street is accurate- no one could keep up with Bob!

We are all left with rich memories and Bob's enduring example of determination, compassionate service to others, and love for being outdoors. The Bob Stockton Trail will commemorate Bob's life and legacy for our entire community, and I sincerely thank you for your consideration.
