SUBJECT: BID NO. 7758 FOR THE CONSTRUCTION OF SIERRA STREET STORM DRAIN IMPROVEMENTS TO MCC EQUIPMENT RENTALS INC, IN THE AMOUNT OF \$283,233.84

ISSUE:

Award Bid No. 7758 for the construction of Sierra Street Storm Drain Improvements to MCC Equipment Rentals, Inc, of Yucaipa, California in the amount of \$283,233.84.

RECOMMENDATIONS:

That the City Council:

- 1. Award a construction contract for Bid No. 7758 for the construction of Sierra Street Storm Drain Improvements to MCC Equipment Rentals, Inc, of Yucaipa, California in the amount of \$283,233.84; and
- 2. Authorize the City Manager, or his designee, to execute the construction contract with MCC Equipment Rentals, Inc, including making minor and non-substantive changes.

BACKGROUND:

The project site is located on Sierra Street between Streeter Avenue and Capistrano Way (Attachment 1). During heavy rain, Sierra Street floods into private properties between Streeter Avenue and Capistrano Way. The installation of the new storm drain line under Sierra Street will alleviate the flooding concerns.

DISCUSSION:

On June 4, 2020, Bid No. 7758 for the Sierra Street Storm Drain Improvements was posted on PlanetBids to construct approximately 900 linear feet of new storm drain line and ancillary structures, under Sierra Street. The new storm drain line will join an existing storm drain catch basin on Sierra Street approximately 40 feet east of Streeter Avenue.

On June 29, 2020, 17 bids were received for the construction of the project (Attachment 2). The lowest responsive bid was from MCC Equipment Rentals, Inc, in the amount of \$283,233.84,

which is 11.75% under the Engineer's Estimate.

The Purchasing Manager concurs that the recommendation to award is in compliance with Purchasing Resolution 23256.

FISCAL IMPACT:

The estimated total project cost including design, construction, construction engineering, and contingencies is \$450,000. Sufficient funds are available in Fund 230 - Special Gas Tax, project account number 9913727-440223 (Sierra Street Storm Drain Improvements) to award the contract and complete the Project.
