Dear Councilmember Edwards,

I understand that City Council will soon discuss raising the rate for waste management. If raising the rate means preserving our current services, then I am comfortable with doing that. I've seen other cities drop their recycling programs, and we can't do that in Riverside. We need to have a safe, sustainable environment.

I also have ideas to reduce expenses. I would suggest that City Council fund educational programs for our neighbors to learn what exactly is recyclable and what is not, because I know that sorting out the trash takes extra time and money that could be otherwise saved. Finally, I recommend that the City invest in composting as another way to cut down on garbage for the landfill and on costs. I appreciated the free workshop I was able to attend, I think provided by the County, that taught me about composting and gave me a very low-priced bin for my composted materials. Perhaps that could be advertised more. When I lived in an apartment in New York City, I brought my compostable materials to my local farmer's market. Perhaps we could do that in Riverside too, for people who can't compost at home.

I have appended below the research I conducted on waste management, and I hope this information is useful to you.
