RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA DIRECTING THE CITY ATTORNEY TO INFORM THE CITY COUNCIL OF THE OPTION TO USE OTHER COUNSEL BEFORE ADVISING ON ISSUES AFFECTING CHARTER OFFICERS.

WHEREAS, Section 702 of the City Charter provides that the City Attorney shall have the power and may be required to represent and advise the City Council and all City officers in all matters of law pertaining to their offices; and

WHEREAS, Section 702 of the City Charter also provides that the City Council shall have control of all legal business and proceedings and may employ other attorneys to take charge of any litigation or mater or to assist the City Attorney therein; and

WHEREAS, Rule 1.13 of the Rules of Professional Conduct which govern the practice of law in California provides that "A lawyer employed or retained by an organization shall confirm his or her representation to the concept that the client is the organization itself, acting through its duly authorized directors, officers, employees, members, shareholders, or other constituents overseeing the particular engagement"; and

WHEREAS, the City Attorney, with the City Clerk and City Manager, is one of three Charter Officers who are selected by, and serve at the pleasure of, the City Council; and

WHEREAS, the City Attorney has been, and may again be called upon, to advise on issues affecting all three Charter Officers including him- or herself; and

WHEREAS, while his or her doing so may be fully compliant with applicable conflict of interest laws, the City Council may still prefer in some instances to use other counsel to avoid even the appearance that it might receive less than fully objective legal advice.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside as follows:

Section 1: That when the City Attorney is requested or required to give legal advice to the City Council pertaining to the terms and condition of employment of the Charter Officers, the City Manager, City Attorney, or City Clerk, before doing so, the City Attorney shall advise the City Council whether such advice might affect the terms and conditions of employment of the City Attorney.

<u>Section 2</u>: That if asked to advise the City Council on a matter which might affect the terms and conditions of employment of the City Attorney, the City Attorney shall inform the Council of that
