- <u>Section 4</u>. Certifies that the City of Riverside has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide.
- Section 5. Delegates the authority to the City Manager, or his or her designee, to conduct all negotiations, sign and submit all documents, including, but not limited to applications,
