A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA APPROVING THE APPLICATION FOR PROP 68 STATEWIDE PARK DEVELOPMENT AND COMMUNITY REVITALIZATION PROGRAM GRANT FUNDS FOR THE PATTERSON PARK MASTER PLAN IMPROVEMENT PROJECT.

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Statewide Park Development and Community Revitalization Grant Program, setting up necessary procedures governing the application; and

WHEREAS, successful Applicants will enter into a contract with the State of California to complete the Grant Scope project.

<u>Section 1.</u> Approves the filing of an application for the Patterson Park Master Plan Improvements project ("Project").

<u>Section 2.</u> Certifies that the City of Riverside has or will have available, prior to commencement of any work on the Project included in this application, the sufficient funds to complete the Project if the grant is awarded.

Section 3. Certifies that if the Project is awarded, the City of Riverside has or will have sufficient funds to operate and maintain the Project

<u>Section 4</u>. Certifies that the City of Riverside has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide.

<u>Section 5.</u> Delegates the authority to the City Manager, or his or her designee, to conduct all negotiations, sign and submit all documents, including, but not limited to applications,

3	Section 6. Agrees to comply with all applicable federal, state and local laws, ordinances,
4	rules, regulations and guidelines.
