2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA APPROVING THE APPLICATION  
4 FOR PROP 68 STATEWIDE PARK DEVELOPMENT AND  
5 COMMUNITY REVITALIZATION PROGRAM GRANT FUNDS  
6 FOR THE PATTERSON PARK MASTER PLAN IMPROVEMENT  
7 PROJECT.

8 WHEREAS, the State Department of Parks and Recreation has been delegated the  
9 responsibility by the Legislature of the State of California for the administration of the Statewide  
10 Park Development and Community Revitalization Grant Program, setting up necessary procedures  
11 governing the application; and

12 WHEREAS, said procedures established by the State Department of Parks and Recreation  
13 require the Applicant to certify by resolution the approval of the application before submission of  
14 said application to the State; and

15 WHEREAS, successful Applicants will enter into a contract with the State of California to  
16 complete the Grant Scope project.

17 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside,  
18 hereby:

19 Section 1. Approves the filing of an application for the Patterson Park Master Plan  
20 Improvements project ("Project").

21 Section 2. Certifies that the City of Riverside has or will have available, prior to  
22 commencement of any work on the Project included in this application, the sufficient funds to  
23 complete the Project if the grant is awarded.

24 Section 3. Certifies that if the Project is awarded, the City of Riverside has or will have  
25 sufficient funds to operate and maintain the Project

26 Section 4. Certifies that the City of Riverside has reviewed, understands, and agrees to  
27 the General Provisions contained in the contract shown in the Grant Administration Guide.

28 Section 5. Delegates the authority to the City Manager, or his or her designee, to conduct  
all negotiations, sign and submit all documents, including, but not limited to applications,

1 agreements, amendments, and payment requests, which may be necessary for the completion of the  
2 Grant Scope.

3 Section 6. Agrees to comply with all applicable federal, state and local laws, ordinances,  
4 rules, regulations and guidelines.

5 Section 7. Will consider promoting inclusion per Public Resources Code §80001(b)(8 A-  
6 G).
