

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,
AMENDING CHAPTER 3.30 OF THE RIVERSIDE MUNICIPAL CODE TO
ADD AN ADDITIONAL CATEGORY TO THE SCHEDULE OF
REGULATION, PRODUCTS, AND SERVICES FOR CLASS II BIKE LANE
TEMPORARY ENFORCEMENT SUSPENSION APPLICATIONS

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 3.30.030 of the Riverside Municipal Code is amended as follows:

“Section 3.30.030 Schedule of Regulation, Products and Services.

A. The City Clerk, City Manager, Chief Finance Officer and each City department head, under the direction of the City Manager, shall review annually the regulations, products and services of the City and the fees and service charges imposed by the City or recommended to be imposed by the City, and provide an adjusted fee or charge schedule to the City Council for its consideration so as to recover the percentage of costs reasonably borne as set forth in the Master Fees and Charges Schedule as necessary to provide the listed regulation, product or service:

Regulation, Product or Service

...

XI. PUBLIC PARKING - PUBLIC WORKS :. .

4151 Class II Bike Lane Parking Enforcement Temporary Suspension

...”

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
