This FIRST AMENDMENT TO MASTER PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("First Amendment") is made and entered into this 29 day of September ~~June~~, 2020, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and HILLTOP GEOTECHNICAL, INC., a California corporation ("Consultant"), with reference to the following facts:

**RECITALS**

- A. WHEREAS, on September 23, 2015, City and Consultant entered into that certain Master Professional Consultant Services Agreement ("Agreement"); and
- B. WHEREAS, Paragraph 2 of the Agreement provides that the Agreement term shall remain in effect until June 30, 2020; and
- C. WHEREAS, City has been satisfied with Consultant's services under the Agreement; and
- D. WHEREAS, City and Consultant desire to extend the term of the Agreement for one year, to remain in effect until June 30, 2021; and
- E. WHEREAS, Paragraph 24 of the Agreement states that the Agreement may be modified or amended by a written agreement executed by Consultant and City.

NOW THEREFORE in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Instructor mutually agree as follows:

- 1. Paragraph 2 of the Agreement, Term, is deleted in its entirety and replaced with the following:
  - "2. **Term.** This Agreement shall be effective on the date first written above and shall remain in effect until June 30, 2021, unless otherwise terminated pursuant to the provisions herein."
- 2. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect, and are hereby incorporated by reference into this First Amendment as though set forth in full herein.
