RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated October 23, 2017 ("Agreement"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated April 30, 2018 ("First Amendment"); and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated October 17, 2019 ("Second Amendment"); and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement by one (1) additional year through June 30, 2021, in the amount of One Hundred Ninety-Five Thousand Four Hundred Thirty-Two Dollars (\$195,432).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 1, Scope of Services, is hereby amended to revise Exhibit A, Section F.1d. to read:
 - "d. Clean at least 100 miles of streets through the Adopt-A-Street Program,"
- 2. Section 2, Term, is hereby amended to extend the term of the Agreement by one (1) additional year through June 30, 2021.
- 3. Section 3, Compensation/Payment, compensation for the extended term will be in the amount of One Hundred Ninety-Five Thousand Four Hundred Thirty-Two Dollars (\$195,432).

4. All other terms and conditions of the Agreement and Amendments between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
