PROPOSITION 68 UPDATE

- 1. Park Development and Revitalization Program is funded through California Drought, Water, Parks, Climate, Coastal Protection and Outdoor Access for All Act of 2018.
- 2. Goal is to Create new parks and recreation opportunities in underserved communities.
- 3. The Parks Recreation Department submitted three applications for Low Park, Myra Linn Park and Patterson Park.
- 4. Applications were not awarded. The State of California Department of Parks and Recreation received 472 applications and awarded 68



PROPOSITION 68 UPDATE

- 1. The Department met with the State to discuss strengths and weaknesses on previous applications.
- 2. The Department will revise their applications and re-submit the applications for Low, Mayra Linn and Patterson Parks
- 3. Per Capita funding of \$177,952 is available and will be used to refurbish the turf at Bobby Bonds Park.
- 4. Community Development Block grant funds in the amount of \$401,345 will supplement the turf refurbishment cost.



- 6. Leave Park as is (Prefer Open









