Following discussion, it was moved by Member Huerta and seconded by Member Vega to encourage the City Clerk to draw Hearing Panel names in a public forum and provide notice to the respondent and complainant so they may observe the drawing. The motion carried unanimously.

Following discussion, it was moved by Member Foley and seconded by Member Huerta that no action be taken on the current designation of the City Clerk to determine completeness of complaints. The motion carried unanimously.

#### AMENDMENT OF COMPLAINT AFTER FILING

Following discussion, it was moved by Vice-Chair Stahovich and seconded by Member Huerta to refer discussion of amending complaints after filing to an ad hoc committee. The motion carried unanimously.

Following discussion, it was moved by Member Huerta and seconded by Member Foley that sufficient resources already exist and no action is needed on the Board of Ethics Chair appointment of a person to assist the public with "complete" complaint filing. The motion carried unanimously.
