DISCUSSION AND ACTION CALENDAR

Item 6 Ordinance to amend Title 9 of the Riverside Municipal Code by adding Chapter 9.75 Establishing the Rules of Library Conduct

Library Director Christmas indicated that the Riverside Public Library already has the established Rules of Library Conduct as described in the ordinance for the successful running of its facilities, to maintain an appropriate library environment, and to ensure customers enjoy their library visits. The Rules of Library Conduct are used by library staff in maintaining a positive and appropriate library environment. The activities in the ordinance are those that a reasonable person would find disruptive to the normal functions being carried on at the library are prohibited.

The ordinance, if approved by the City Council, will protect the rights of library customers, staff and volunteers.

Deputy City Attorney Hanna indicated that the additions were mainly to clarify that certain activities are crimes and cited with the penal codes such as drunk in public, indecent exposure, etc. This would allow the police to treat such crimes as misdemeanors.

Following review and discussion of the ordinance, the Board of Library Trustees voted to recommend that the City Council approve amending Title 9 of the Riverside Municipal Code by adding Chapter 9.75 Establishing the Rules of Library Conduct.

The Library Director will return in January 2021 to revisit the meeting date and time.
