SUBJECT: REPORT OUT FROM COMMUNITY POLICE REVIEW COMMISSION 2020 BY-LAWS REVIEW AD HOC COMMITTEE AND DISCUSSION OF RECOMMENDED REVISIONS

ISSUES:

Review, provide input, and approve recommended revisions from the Community Police Review Commission 2020 By-Laws Review As Hoc Committee to the Community Police Review Commission By-Laws.

RECOMMENDATIONS:

That the Community Police Review Commission review, provide input, and approve recommended revisions from the Community Police Review Commission 2020 By-Laws Review As Hoc Committee to the Community Police Review Commission By-Laws.

BACKGROUND:

On September 23, 2020, the Community Police Review Commission (CPRC) 2020 By-Laws Review Ad Hoc Committee was created by Chair Smith. Chair Smith declared that the intention of the Ad Hoc Committee was for the 2020 review of the CPRC Bylaws by the end of the 2020 calendar year. Chair Smith appointed Commissioner Berrellez as chair of the committee, and Commissioner De Brier as a member of the committee. Commissioner Teichert will be appointed as a member of the committee during the October CPRC meeting.

A discussion item will be placed on each CPRC agenda to receive a report from the Community Police Review Commission 2020 By-Laws Review Ad Hoc Committee; discuss recommended revisions to the Community Police Review Commission By-Laws or Policies and Procedures, if any, and schedule actions as needed for a future Community Police Review Commission meeting.

On October 28, 2020, Chair Smith appointed Commissioner Teichert as a member of the committee. Commissioner Berrellez stated that there were no recommend changes to the CPRC By-Laws or Policies and Procedures at this time, but that further review would be conducted. The CPRC unanimously voted to receive the report and forward this item to the next CPRC meeting.

On November 18, 2020, Commissioner Teichert introduced proposed changes to the CPRC By-Laws as indicated on the attached red-line version of the CPRC By-Laws. The CPRC unanimously voted to formerly review the proposed changes at the next CPRC meeting.

DISCUSSION:

The CPRC 2020 By-Laws Review Ad Hoc Committee will be asked to provide an update on their activities, discuss with the full Commission any recommended changes to the By-Laws or the Policies and Procedures and schedule actions as needed for future CPRC meetings.

Edits to the By-Laws, introduced at the November 18, 2020 CPRC Meeting, with be formerly reviewed today for input and approval. The proposed edits can be found on the attached red-line version of the CPRC By-Laws. Article's amended include:

- Article V – Commission Officers
- Article VII – Meetings
- Article VII – Investigations and Hearings
