#### RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated December 21, 2018 ("Agreement") for Third Street Grade Separation at BNSF Railroad ("Project"); and

WHEREAS, the City and Consultant entered into the First Amendment to Professional Services Agreement dated July 15, 2020 to add additional services to the Scope of Work; and

WHEREAS, the City desires to amend the agreement to extend the term of the agreement; and

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 1, Scope of Services, is hereby amended as described in Exhibit "A-2" attached hereto and incorporated herein.
- 2. Section 4, Term, is hereby amended to extend the term of the Agreement to June 31, 2021.
- 3. Section 5, Compensation/Payment, is hereby amended to increase the compensation by Nineteen Thousand Five Hundred Dollars (\$19,500.00) for the additional Services.
- 4. All other terms and conditions of the Agreement and the First Amendment between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
