WHEREAS, the City and Contractor entered into the Memorandum of Understanding as a Sub-Grantee Agreement of the California Department of Resources Recycling and Recovery (CalRecycle) Food Waste Prevent and Rescue Grant Program ("MOU") approved by the City Council on August 8, 2017; and

WHEREAS, the corresponding grant agreement between the City and CalRecycle was amended to extend its term to April 1, 2021; and

WHEREAS, the City and Contractor desire to extend the term of the MOU to January 1, 2026 to be consistent with the corresponding grant agreement between the City and CalRecycle and to accommodate potential future grant extensions from CalRecycle.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the MOU.

- 1. Section II., MOU Term, is hereby amended to extend the term of the MOU to January 1, 2026.
- 2. All other terms and conditions of the MOU between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
