BEC MEETING DATES

ISSUE:

Budget Engagement Commission's role in the development of the Fiscal Year (FY) 2021/22 budget and schedule special meeting dates for the receipt of City departments' proposed budget presentations.

RECOMMENDATIONS:

That the Budget Engagement Commission:

- Discuss the Budget Engagement Commission's role in the development of the FY 2021/22 budget; and
- 2. Schedule special meeting dates for the receipt of City departments' proposed budget presentations.

BACKGROUND:

In prior budget development years, the Budget Engagement Commission (BEC) received numerous presentations from individual departments and provided feedback to City departments on the spending priorities of the City. During the development of the FY 2020/21 Emergency Budget, the scheduled BEC meetings were cancelled due to the COVID-19 pandemic and staff was not able to accommodate the usual level of engagement in the budget process.

DISCUSSION:

The development of the FY 2021/22 Annual Budget is currently underway. The public meeting schedule for proposed budget presentations is as follows:
