1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED NO PARKING ZONE ON HORIZON VIEW DRIVE. 4 WHEREAS, the Public Works Department received a petition from eighty percent (80%) 5 of impacted residents on Horizon View Drive and Choi Drive requesting the establishment of a 6 "No Parking between the hours of 8:00 p.m. to 6:00 a.m. daily" zone along both sides of Horizon 7 View Drive from Choi Drive to the southerly terminus; and 8 WHEREAS, residents indicate nighttime parking generates undesirable and illegal activity 9 and littering; and 10 WHEREAS, the establishment of the proposed Timed No Parking zone would restrict late 11 night and early morning parking along both sides of Horizon View Drive from Choi Drive to the 12 southerly terminus; and 13 WHEREAS, on November 4, 2020, the Transportation Board unanimously recommended 14 the establishment of the proposed Timed No Parking zone on the designated segment of Horizon 15 View Drive. 16 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 17 California, as follows: 18 <u>Section 1</u>: The recitals set forth above are incorporated herein by reference. 19 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No 20 Parking between the hours of 8:00 p.m. to 6:00 a.m. Daily" zone on both sides of Horizon View 21 22 Drive from Choi Drive to the southerly terminus. 23 Section 3: That the provisions of this resolution shall be operative only when signs are 24 erected on that portion of the street set forth in Section 2 above, giving notice of the parking 25 limitations or prohibitions herein established. 26 Section 4: The provisions of this amendment shall be operative as of the date of adoption 27 of this resolution. 28
