PURCHASE AND SALE AGREEMENT - KRAMERIA SEWER PUMP STATION - VAN BUREN BOULEVARD SEWER INSTALLATION PROJECT - 16476 WASHINGTON/VAN BUREN

Following discussion, it was moved by Councilmember Conder and seconded by Councilmember Melendrez to (1) approve a Services Agreement for RFP No. 2025 for utility potholing services to Aztec Engineering California, Inc., in an amount not-to-exceed \$147,810 for a term through December 31, 2022; (2) authorize the City Manager, or his designee, to execute the Services Agreement with Aztec Engineering California, Inc., including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transaction; (3) approve the Purchase and Sale Agreement with Western Municipal Water District for acquisition of 16476 Washington Street, identified as APN 274-040-051 for the purchase price of \$62,000, plus \$10,000 for due diligence, title, escrow, and related closing costs, for a total amount not-to-exceed \$72,000; (4) authorize the City Manager, or his designee, to execute the Purchase and Sale Agreement with Western Municipal Water District, including making minor, nonsubstantive changes, and to sign all documents and instruments necessary to complete the transaction; (5) receive and order filed the Van Buren Boulevard Sewer Installation Project update; and (6) direct the City Manager to work with the County of Riverside to find County funding sources and explore grant opportunities with an update to the City Council prior to Spring of 2021. The motion carried unanimously.

FISCAL YEAR 2019-20 - FOURTH QUARTER FINANCIAL REPORT AND MEASURE Z UPDATE - FUNDS CARRY-OVER

Following discussion, it was moved by Councilmember Hemenway and seconded by Councilmember Fierro to (1) receive and ordered filed the Fiscal Year 2019/20 Fourth Quarter Financial Report and Measure Z update; (2) approve a carryover of unexpended funds of approximately \$1.3 million in the General Fund and \$32.9 million in other City

funds into fiscal year 2020/21; and (3) direct staff to place \$15.6 million of surplus reserves into a restricted undesignated fund. The motion carried unanimously.

STATE OF CALIFORNIA HOMELESS HOUSING, ASSISTANCE AND PREVENTION PROGRAM ROUND 2 FUNDING - PALLET SHELTERS - BRIDGE HOUSING PROGRAM - SUPPLEMENTAL APPROPRIATION

The City Council (1) authorized submission of a grant application to the State of California for the Homeless Housing, Assistance and Prevention Program Round 2 funding in the amount of \$3,262,879 to provide homeless and housing services in the City of Riverside that include the recommendations provided by the Housing and Homelessness Committee; (2) upon grant award, authorized acceptance of the Homeless Housing, Assistance and Prevention Program Round 2 grant award from the State of California, including amounts lesser or greater than the amount applied for; (3) upon grant award, authorized an increase in revenue in the amount awarded to Development Grants Fund, HHAP2 Program Account No. 9343200-334100 and appropriated expenditures in the same fund and amount to the accounts identified under the Fiscal Impact section of the written staff report; (4) authorized the City Manager, or his designee, to execute all grant documents related to the Homeless Housing, Assistance and Prevention Program Round 2, including making minor, non-substantive changes; (5) authorized the City Manager, or his designee, to execute grant subrecipient documents with City Net in an amount not-to-exceed \$1,000,000 for operation of the Pallet Shelters; and (6) authorized the City Manager, or his designee, to execute grant subrecipient documents with Mercy House in an amount not-to-exceed \$1,000,000 for operation of the Bridge Housing Program.

The City Council (1) approved submission of a grant application in an amount up to \$30,000 to the State of California, Office of Traffic Safety for Fiscal Year 2021-22; (2) upon grant award, authorized an increase in estimated revenues in an amount up to \$30,000 in Fund 215 Grants and Restricted Programs Police Department Revenue Account and appropriated expenditures in the same amount to the Fund 215 Grants and Restricted Programs Police Department Expenditure Account; and (3) authorized the City Manager, or his designee, to execute the grant documents with the State of California, Office of Traffic Safety, including making minor and non-substantive changes.

AGREEMENT - RIVERSIDE ART MUSEUM - CHEECH MARIN CENTER FOR CHICANO ART AND CULTURE - 3581 MISSION INN

Following discussion, it was moved by Councilmember Edwards and seconded by Councilwoman Plascencia to (1) approve the Management Agreement for The Cheech Marin Center for Chicano Art and Culture with Riverside Art Museum for an initial term of 25 years with two optional five-year terms; (2) authorize the City Manager, or his designee, to execute the Management Agreement with Riverside Art Museum, including making minor and non-substantive changes; (3) award Bid 7764 to Hamel Contracting Inc., Murrieta, California for \$9,729,411 to renovate the existing Main Library located at 3581 Mission Inn Avenue into The Cheech Marin Center for Chicano Art and Culture; (4) authorize a 10 percent contingency of \$972,941 for project changes including unforeseen site conditions or necessary design changes; (5) authorize the City Manager, or his designee, to execute the Construction Agreement with Hamel Contracting Inc., Murrieta, CA, including making minor and non-substantive changes; and (6) direct staff to explore other economic development activities in surrounding spaces. The motion carried with Councilmembers Edwards, Perry, and Hemenway, and Councilwoman Plascencia voting aye, Councilmember Conder abstaining, and Councilmembers Melendrez and Fierro disqualified.
