2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AUTHORIZING THE SUBMISSION OF APPLICATION  
4 AND ACCEPTANCE OF GRANT AWARD FROM THE UNITED STATES  
5 DEPARTMENT OF HOMELAND SECURITY THROUGH THE  
6 CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR  
7 THE FISCAL YEARS 2020, 2021, AND 2022 URBAN AREAS SECURITY  
8 INITIATIVE (UASI) HOMELAND SECURITY GRANT PROGRAM AND  
9 AUTHORIZING THE EXECUTION OF ALL REQUIRED DOCUMENTS  
10 BY THE CITY MANAGER, ASSISTANT CITY MANAGER, OR FIRE  
11 CHIEF; AND AMENDING THE BUDGET FOR FISCAL YEARS 2020-  
12 2021, 2021-2022, AND 2022-2023 ACCORDINGLY.

13 WHEREAS, the United States Department of Homeland Security (the "Grantor"), through the  
14 California Governor's Office of Emergency Services, has heretofore invoiced public agencies,  
15 including the City of Riverside ("City"), to submit applications to the Grantor for the Fiscal Years  
16 2020, 2021, and 2022 Urban Areas Security Initiative (UASI) Homeland Security Grant Program (the  
17 "Grant"); and

18 WHEREAS, the City is familiar with the terms, conditions and limitations of such Grant;

19 WHEREAS, the City is willing and able to conform to each of the terms, conditions, and  
20 limitations imposed upon such Grant to the City;

21 WHEREAS, the City desires to apply for, and upon grant award, accept the grant award from  
22 the Grantor in the amount of \$2,894,500; and

23 WHEREAS, the City Council desires to amend the City's budget to reflect and incorporate the  
24 Grant so awarded to the City, and to increase the annual appropriations and expenditures in the  
25 appropriate City program(s) to reflect such award.

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
27 California, as follows:

28 Section 1: The City Manager, Assistant City Manager, or Fire Chief are hereby authorized to  
submit a grant application for and on behalf of the City of Riverside, and is hereby authorized to  
execute all actions necessary for the purpose of obtaining federal financial assistance provided by the  
United States Department of Homeland Security and sub-granted through the State of California,  
including any extensions and amendments thereof.

Section 2: The City Council of the City of Riverside hereby agrees to, and by this resolution, does accept the Grant funds in the amount of \$2,894,500 awarded to the City of Riverside.

Section 3: The City of Riverside hereby agrees to comply with each and all of the terms, conditions, and limitations imposed by the Grantor upon said Grant, and the City of Riverside City Manager, Assistant City Manager, or Fire Chief are hereby authorized and directed to execute the Signature Authority document attached as well as any agreements, assurance, or other documents as may be necessary in connection with acceptance and implementation of said Grant as may be required by the Grantor.
