#### MINUTES

#### AGREEMENT - NURSE OUTREACH WORK PROGRAM SERVICES

The City Council (1) approved a Nurse Outreach Services Agreement with Riverside University Health System for the Nurse Outreach Worker Program to provide basic health care to individuals experiencing homelessness in the City of Riverside in the amount not-to-exceed \$355,828.78, for a one-year term with two optional one-year extensions; and (2) authorized the City Manager, or his designee, to execute the Nurse Outreach Services Agreement with Riverside University Health System, including the authority to execute the two optional one-year extensions subject to the availability of budgeted funds and to make any minor and non-substantive changes.

CONDUCT ON PUBLIC PROPERTY - DECORATIVE FOUNTAINS - ORDINANCE ADOPTED The City Council adopted an ordinance amending Section 9.04.400(D) of the Riverside Municipal Code regarding conduct on public property adding language to prohibit

entering the water, shaving, washing clothes, or otherwise polluting any decorative fountain, or allowing any minor child or pet to do the same; whereupon, the title having been read and further reading waived, Ordinance No. 7548 of the City of Riverside, California, Amending Section 9.04.400(D) of the Riverside Municipal Code Regarding Conduct on Public Property," was presented and adopted.

SPEED LIMIT ZONE - GREEN ORCHARD/KINGDOM/CRYSTAL VIEW - ORDINANCE ADOPTED The City Council adopted an Ordinance amending Section 10.76.010 of the Municipal Code designating the prima facie speed limits for streets and portions thereof in accordance with the provisions of sections 10.20.020 and 10.20.030 to establish a 35 mph speed limit zone on Green Orchard Place from Kingdom Drive to Crystal View Terrace; whereupon, the title having been read and further reading waived, Ordinance No. 7549 of the City of Riverside, California, Amending Section 10.76.010 of the Riverside Municipal Code Designating the Prima Facie Speed Limits for Streets and Portions Thereof in Accordance with the Provisions of Sections 10.20.020 and 10.20.030," was presented and adopted.

### **DISCUSSION CALENDAR**

RIVERSIDE TRANSMISSION RELIABILITY PROJECT - SUPPLEMENTAL APPROPRIATION Following discussion, it was moved by Councilmember Conder and seconded by Councilmember Fierro to (1) approve a supplemental appropriation in the amount of \$125,000,000 from the Electric Fund (Fund 510) to Riverside Transmission Reliability Project Account No. 6130000-470685 to be funded for the Riverside Transmission Reliability Project components, including the Wilderness Substation, line work, and associated components as presented herein; and (2) direct staff to continue research on options and conduct community meetings. The motion carried with Councilmembers Edwards, Melendrez, Fierro, Conder, Perry, and Councilwoman Plascencia voting age and Councilmember Hemenway voting no.
