

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH TIMED 2-  
5 HOUR, TIMED NO PARKING, AND PASSENGER LOADING ZONES ON  
6 MARKET STREET.

7 WHEREAS, the Public Works Department received a request from The Centerpointe  
8 Apartments, located at 3145 Market Street, to establish multiple timed parking zones and a  
9 passenger loading zone at the frontage of their facility along Market Street, between First Street  
10 and Second Street; and

11 WHEREAS, the establishment of a timed 2-hour parking zone will provide tenants and  
12 their guests with conveniently located parking at the frontage of the complex while ensuring  
13 greater turnover and availability of on-street parking opportunities; and

14 WHEREAS, the establishment of a timed no parking zone would increase safety, decrease  
15 nighttime noise concerns, and create consistency of night-time parking regulations with existing  
16 regulations in the immediate area; and

17 WHEREAS, the establishment of a passenger loading zone would provide postal service  
18 personnel with immediate access to the complex's internal mail facilities; and

19 WHEREAS, on February 3, 2021, the Transportation Board was cancelled by the Board  
20 Chairman due to insufficient agenda items and to avoid delays in the processing of this request,  
21 the item has been taken directly to City Council for consideration.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
23 California, as follows:

24 Section 1: The recitals set forth above are incorporated herein by reference.

25 Section 2: That the Master Parking Schedule is hereby amended by 1) establishing the "2-  
26 Hour Parking between the hours of 9:00 a.m. to 6:00 p.m. Daily" zone on the west side of Market  
27 Street from 131 feet south of First Street to 56 feet north of Second Street; 2) establishing the "No  
28 Parking between the hours of 10:00 p.m. to 4:00 a.m. Daily" zone on the west side of Market  
Street from 131 feet south of First Street to 56 feet north of Second Street; and 3) establishing the

1 “No Parking Passenger Loading” zone on the west side of Market Street from 76 feet south of  
2 First Street to 56 feet north of Second Street.

3 Section 3: That the provisions of this resolution shall be operative only when signs are  
4 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
5 limitations or prohibitions herein established.

6 Section 4: The provisions of this amendment shall be operative as of the date of adoption  
7 of this resolution.
