The City Council has reviewed the matter and, based upon the facts and Section 2: 10 information contained in the staff reports, administrative record, and written and oral testimony, 11 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 12 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 13 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change. 14 15 The City Clerk shall certify to the adoption of this ordinance and cause 16 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside.
