## THIRD AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE SERVICES FOR FREEWAY ON AND OFF RAMPS

## RECITALS

WHEREAS, on or about July 25, 2016, City and Contractor entered into that certain Landscape Maintenance Services Agreement ("Services"). For Landscape Maintenance on Freeway On and Off Ramps, and

WHEREAS, on or about April 4, 2019, City and Contractor entered into that certain First Amendment to extend the term of the Agreement for and additional one (1) year period; and

WHEREAS, on or about March 10, 2020, City and Contractor entered into that certain Second Amendment to extend the term of the Agreement for and additional one (1) year period; and

WHEREAS, the City and Contractor desire to extend the Agreement for an additional one (1) year, until June 30, 2022 with compensation for this additional time period not to exceed Eighty-Eight Thousand Dollars (\$88,000).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

- 1. Section 2, Term of the Agreement is amended to extend the term by one year, to expire on June 30, 2022.
- 2. Section 3, Compensation/Payment, is amended to increase the compensation by Eighty-Eight Thousand Dollars (\$88,000.00) for the extended one-year term,
- 3. All other terms and conditions of the Agreement, and its amendments, between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
