RECITALS

WHEREAS, on or about June 15, 2018, City and Contractor entered into that certain Services Agreement ("Services"), for Downtown Area Water Features — Main Street Mall between Tenth Street and Sixth Street; and

WHEREAS, on or about April 3, 2019, City and Contractor entered into that certain First Amendment to extend the term of the Agreement for an additional one (1) year period; and

WHEREAS, on or about March 10, 2020, City and Contractor entered into that certain Second Amendment to extend the term of the Agreement for (1) additional year; and

WHEREAS, the City and Contractor desire to extend the Agreement for an additional one year, until June 30, 2022.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

- 1. Section 2, Term of the Agreement is amended to extend the term by one year, to expire on June 30, 2022.
- 2. Section 3, Compensation, is amended to increase the compensation by Thirty-Seven Thousand Three Hundred Dollars (\$37,300) for the extended one-year term, for a contract total of an amount not to exceed One Hundred Fifty-One Thousand Six Hundred Dollars (\$151,600).
- 3. All other terms and conditions of the Agreement, and its amendments, between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
