WHERAS, section 14.12.495 provides that the Enforcement Response Plan is to be adopted by resolution of the City Council; and

WHEREAS, on September 19, 2006, the City adopted Resolution No. 21255, adopting the City's current Enforcement Response Plan, which was later updated in 2009; and

WHEREAS, the Enforcement Response Plan must be periodically reviewed and amended to incorporate changes in the pretreatment program's enforcement actions and procedures; and

WHEREAS, changes to the Enforcement Response Plan include designated employee changes, creation of a tiered enforcement penalty schedule, improved clarity of enforcement procedures, additional enforcement actions and an improved enforcement matrix summary; and

WHEREAS, the changes to the Enforcement Response Plan have been approved by the California Regional Water Quality Control Board, Santa Ana Region; and

WHEREAS, staff now recommends that the City Council adopt the revised Enforcement Response Plan, and repeal Resolution No. 21255.
