## SUBJECT: CONDUCT ELECTION FOR MUSEUM OF RIVERSIDE BOARD OFFICERS

### ISSUE:

Conduct election for Museum of Riverside Board officers.

#### **RECOMMENDATIONS:**

That the Museum of Riverside Board:

- 1. Receive nominations for Museum of Riverside Board officers as recommended by the Board Development Committee; and
- 2. Elect the Chair and Vice-Chair positions to begin effective immediately.

#### BACKGROUND:

The election of officers is to be conducted annually from the slate proposed by the Board Development Committee (formerly known as the Nominating Committee) or from nominations from the floor. Following the Museum of Riverside Board's Standing Rules, all officers shall be elected by the Board members for a term of one year. A member may serve no more than two successive years in the same office. Terms are scheduled to begin after the office election at the regular March meeting. In 2020, officer elections were delayed due to COVID-19 meeting cancellations during the spring of 2020. Meetings resumed virtually in June 2020, when the current officers were elected.

The Museum Board Development Committee met on January 22, 2021 and nominated Peggy Barnhart for a second term as Chair and Lovelyn Razzouk for a second term as Vice-Chair. The Board Development Committee voted to solicit additional officer nominations at the Board meeting on February 24, 2021 and confirmed that elections would be held at the March 24, 2021 meeting.
