9	WHEREAS, the U.S. Department of Homeland Security (the "Grantor") has been delegated			
10	authority to award federal financial assistance for the Fiscal Year 2020 Emergency Management			
11	Performance Grant Program Supplemental (EMPG-S) Subaward #2020-0019, CFDA# 97.042; and			
12	WHEREAS, said federal funds have been sub-granted to the California Governor's Office of			
13	Emergency Services ("CalOES"); and			
14	WHEREAS, the County of Riverside is the designated Operational Area to which CalOES			
15	grant funds are awarded and distributed; and			
16	WHEREAS, the City desires to apply for and upon grant award, accept the grant award from			
17	the Department of Homeland Security in the amount of \$54,600; and			
18	WHEREAS, the City Council desires to amend the annual budget of the City to reflect and			
19	incorporate the grant so awarded to the City, and to increase the annual appropriations and			
20	expenditures in the appropriate City program to reflect such award.			
21	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,			
22	California, as follows:			
23	Section 1: The City Manager, Assistant City Manager, or City Fire Chief are hereby authorized			
24	to submit a grant application for and on behalf of the City of Riverside, through the County of			
25	Riverside, and is hereby authorized to execute all actions necessary for the purpose of obtaining federal			
26	financial assistance provided by the United States Department of Homeland Security and sub-granted			
27	through the State of California, including any extensions and amendments thereof.

1	Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution			
2	does, accept the Grant funds in the amount of \$54,600 awarded to the City of Riverside.			
3	Section 3: The City of Riverside hereby agrees to comply with each and all of the terms,			
4	conditions, and limitations, imposed by the Grantor upon said Grant, and the City of Riverside City			
5	Manager, or an Assistant City Manager, or the City Fire Chief are hereby authorized and directed to			
6	execute the Signature Authority documents as well as any agreements, assurance, or other documents			
7	as may be necessary in connection with acceptance and implementation of said Grant as may be			
8	required by the Grantor.			
9	Section 4: The annual budget of the City of Riverside for fiscal year 2020-2021 is hereby			
10	amended by increasing the appropriations and authorized expenditures in such amount as is equal to			
11	the amount of Grant funds to be received by the City.
