Casa Blanca Street, on the south side of Indiana Avenue, north side of Casa Blanca Street, and west of Winstrom

Street, in Ward 4.

**PROPOSAL:** Permit the following entitlements for the expansion of the existing Harley-Davidson dealership building: 1) General Plan Amendment for a portion of the lots located at 7681 and 7691 Casa Blanca Street to change the land use designation from MDR-Medium Density Residential to CRC-Commercial Regional Center; 2) Specific Plan Amendment to include a portion of the lots located at 7681 and 7691 Casa Blanca Street into the boundaries of the Riverside Auto Center Specific Plan; 3) Zoning Code Map Amendment to rezone a portion of the lots located at 7681 and 7691 Casa Blanca Street from R-1-7000 - Single Family Residential Zone to CG-S-2-X-25-SP-Commercial General, Building Stories (maximum of 2 Stories), Building Setback (25 feet), and Specific Plan (Riverside Auto Center) Overlay Zones; 4) Design Review of project plans; and 5) Variance to allow a reduced lot area for the conversion from residential to commercial zoning in the Riverside Auto Center Specific Plan.

**ENVIRONMENTAL DETERMINATION:** The Planning Commission recommends finding that this project will not have a significant effect on the environment based on the findings set forth in the case record and
