RECITALS

WHEREAS, on July 28, 2015, City and ValleyCrest Landscape Maintenance, Inc. entered into an Agreement For Landscape Maintenance Services For Municipal Parking Facilities (Exterior Only) ("Agreement"), wherein Contractor agreed to provide landscape services for Municipal Parking Facilities (Exterior Only); and

WHEREAS, on November 16, 2016, City and BrightView Landscape Services, Inc. entered into a First Amendment to Agreement for Landscape Maintenance Services for Municipal Parking Facilities (Exterior Only) ("First Amendment") wherein the parties agreed to amend the name of Contractor for the Agreement from ValleyCrest Landscape Maintenance, Inc. to BrightView Landscape Services, Inc.; and

WHEREAS, on May 31, 2018, City and BrightView Landscape Services, Inc. entered into a Second Amendment to Agreement for Landscape Maintenance Services for Municipal Parking Facilities (Exterior Only) ("Second Amendment") wherein the parties agreed to extend the term of the agreement for one (1) year from July 1, 2018 to June 30, 2019.; and

WHEREAS, on May 10, 2019, City and BrightView Landscape Services, Inc. entered into a Third Amendment to Agreement for Landscape Maintenance Services for Municipal Parking Facilities (Exterior Only) ("Third Amendment") wherein the parties agreed to extend the term of the agreement for one (1) year from July 1, 2019 to June 30, 2020.; and

WHEREAS, on March 10, 2020, City and BrightView Landscape Services, Inc. entered into a Fourth Amendment to Agreement for Landscape Maintenance Services for Municipal Parking Facilities (Exterior Only) ("Fourth Amendment") wherein the parties agreed to extend the term of the agreement for one (1) year from July 1, 2020 to June 30, 2021.; and

WHEREAS, the parties desire to extend the term of the Agreement for one (1) additional year, from July 1, 2021, to June 30, 2022; and

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor mutually agree as follows:

- 1. Section 2 of the Agreement is hereby amended to extend the term for one (1) additional year, from July 1, 2021, to June 30, 2022.
- 2. Section 3 of the Agreement is hereby amended to increase the compensation in the amount not to exceed Seventy-Four Thousand Forty-Four Dollars (\$74,044).
- 3. All terms and conditions of the Agreement and its amendments not inconsistent herewith shall remain in full force and effect and are hereby incorporated by reference into this Fifth Amendment as though set forth in full herein.
