ORDINANCE NO. 1 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING 2 THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 3 19.090 OF THE RIVERSIDE MUNICIPAL CODE TO REMOVE THE EMERGENCY SHELTER (ES) OVERLAY ZONE DESIGNATION FROM THE APPROXIMATELY 4 1.8-ACRE HULEN PLACE COMMUNITY SHELTER CAMPUS AT 2800 - 2881 HULEN PLACE, LOCATED ON THE NORTH SIDE OF MASSACHUSETTS 5 AVENUE, RIVERSIDE, CALIFORNIA. 6 The City Council of the City of Riverside, California, does ordain as follows: 7 Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of 8 the City of Riverside is amended by removing the Emergency Shelter (ES) Overlay Zone 9 designation from the approximately 1.8-acre Hulen Place Community Shelter Campus at 2800 – 10 2881 Hulen Place, located on the north side of Massachusetts Avenue, as described and depicted in 11 Exhibit "A" attached hereto and incorporated herein by reference, subject to all of the conditions, 12 restrictions and covenants imposed under Planning Case Number DP-2020-00219, which conditions, 13 restrictions and covenants are incorporated herein by reference. 14 Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause 15 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 16 of the City of Riverside.
