

**THIRD AMENDMENT
TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT**

HUB INTERNATIONAL INSURANCE SERVICES, INC.

Employee Benefit Consulting and Underwriting Services

THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Third Amendment") is made and entered into this ____ day of _____, 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and HUB INTERNATIONAL INSURANCE SERVICES, INC., a California corporation ("Consultant").

RECITALS

A. On August 13, 2014, City and Consultant entered into a Professional Consultant Services Agreement for Employee Benefit Consulting and Underwriting Services ("Agreement").

B. On September 25, 2017, City and Consultant entered into a First Amendment to Professional Consultant Services Agreement ("First Amendment"), extending the term to June 30, 2019.

C. On April 22, 2019, City and Consultant entered into a Second Amendment to Professional Consultant Services Agreement ("Second Amendment"), extending the Agreement to June 30, 2021.

D. City is satisfied with the performance of Consultant and would like to extend the term of the Agreement by an additional three (3) years, through and including June 30, 2024, for an additional compensation amount of Eighty-Five Thousand One Hundred Two Dollars (\$85,102.00).

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

1. Section 2 "Term" of the Agreement is hereby amended to extend the term by three (3) additional years, until June 30, 2024.

2. Section 3 "Compensation" of the Agreement is hereby amended to add the following new paragraph:

"For the term July 1, 2021, to June 30, 2024, compensation shall be Eighty-Five Thousand One Hundred Two Dollars (\$85,102.00). Ten Thousand Dollars (\$10,000.00) of the consulting fee will be applied to wellness consulting/program through HUB International. The annual fee is guaranteed for one (1) year. Additional renewals will have a three percent (3%) annual increase."


3. All terms and conditions of the original Agreement not inconsistent with this Third Amendment to Professional Consultant Services Agreement shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.

IN WITNESS WHEREOF, City and Consultant have caused this Third Amendment to Professional Consultant Services Agreement to be duly executed on the day and year first above written.






